ORDER

WHEREAS, in terms of Section 14(1) of the NCTE Act, 1993, Brilliant Educational Trust, Plot No.113, First Main Road, Balamurugan Gardens, Thuraipakkam Post, Tambaram Taluk, Chennai District, Pin – 600 097, Tamilnadu had submitted an on-line application to the Southern Regional Committee of NCTE on 12.12.2012 and physical application on 12.12.2012 for grant of recognition for B.Ed course of one year duration with an annual intake of 100 students at Brilliant College of Education, Khasara No.153/4, 5, 7, 8, Plot No.3/87-A, Thiruvarur Main Road, Paruthicheri Village, Velur Post, Thiruthuraipoondi Taluk, Thiruvarur District, Pin – 614715, Tamilnadu.

AND WHEREAS, on scrutiny of the application submitted by the institution, the documents attached therewith the affidavit and the input received from the visiting team in the form of report and videography, the committee is satisfied that the institution fulfills the requirements under the provisions of NCTE Act, Rules and relevant Regulations including the Norms and Standards for the said teacher education programme such as instructional facilities, infrastructural facilities, library, accommodation, financial resources, laboratories etc., for running the programme and has appointed duly qualified teaching staff as per NCTE norms.

NOW, THEREFORE, in exercise of the powers vested under Section 14(3) (a) of the NCTE Act, 1993, the Southern Regional Committee, NCTE hereby grants recognition to Brilliant College of Education, Khasara No.153/4, 5, 7, 8, Plot No.3/87-A, Thiruvarur Main Road, Paruthicheri Village, Velur Post, Thiruthuraipoondi Taluk, Thiruvarur District, Pin – 614715, Tamilnadu for conducting B.Ed Course of one year duration with an annual intake of 100 students from the academic session 2014-2015 under clause 7(11) of NCTE (Recognition Norms & Procedure) Regulations, 2009 subject, to fulfillment of the following conditions:

- The endowment fund of Rs.5 lakhs and reserve fund of Rs.3 lakhs kept in joint account with SRC, NCTE should be maintained always. Loan raising or mortgaging of FDRs shall not be done.
- II. The institution shall comply with the various other norms and standards prescribed in the NCTE regulations, as amended from time to time.
- III. The institution shall make admission only after it obtains affiliation from the examining body in terms of clause 8(12) of the NCTE (Recognition Norms & Procedure) Regulations, 2009.
- IV. The institution shall ensure that the required number of academic staff duly approved by affiliating body for conducting the course should always remain in position.
- V. Minority Certificate from the Principal Secretary, Department of Education, Government of Tamilnadu to be submitted within 3 months from the date of issue of this order.
- Further, the recognition is subject to fulfillment of all such other requirements as may be prescribed by other regulatory bodies like UGC, affiliating University/ Body, the State Government etc, as applicable.

- The institution shall submit to the Regional Committee a Self-Appraisal Report at the end
 of each academic year along the statement of annual accounts duly audited by a
 Chartered Accountant.
- 4. The institution shall maintain & update its Web-site as per provisions of NCTE Regulations and always display following as mandatory disclosure:-

(a) Sanctioned programmes along with annual intake in the institution;

(b) Name of faculty and staff in full as mentioned in school certificate along with their qualifications, scale of pay and photograph;

(c) Name of faculty members who left or joined during the last , quarter;

- (d) Names of students admitted during the current session along with qualification, percentage of marks in the qualifying examination and in the entrance test, if any, date of admission, etc.;
- (e) Fee charged from students;
- (f) Available infrastructural facilities;

(g) Facilities added during the last quarter;

- (h) Number of books in the library, journals subscribed to and additions, if any, in the last quarter;
- (i) The institution shall be free to post additional relevant information, if it so desires
- Any wrong or incomplete information on website shall render the institution liable for withdrawal of recognition
- If the institution contravenes any of the above conditions or the provisions of the NCTE Act, Rules, Regulations and Orders made or issued there under, the Regional Committee shall withdraw the recognition as under the provisions of Section 17(1) of the NCTE Act. By Order,
